I. EXECUTIVE SUMMARY

The NY/NJ HIDTA region remains a national distribution hub for illicit drugs, particularly cocaine, heroin and marijuana. The region serves as a distribution center for many northeastern cities as well. Cocaine and heroin pose the most serious threat to the region. They are both readily available and highly abused. Illegal drugs do not discriminate; no societal component is immune from the consequences and ravages of this abuse. Abuse transcends all societal boundaries and affects every ethnic group with no regard for age, gender, zip code or income. The negative consequences have far reaching effects, and impact not only the individual abuser, but families, friends, businesses, and governmental resources as well. All too often our youth fall victim to this scourge.

Death Of 2-Year-Old Ruled A Homicide After Drugs Found In Her System NY1 News, March 01, 2006

The death of a 2-year-old baby in the Bronx in January was ruled a homicide Wednesday after the Medical Examiner found heroin in her system.

Sherlyn Polonia died in January after being brought to the hospital unconscious. Doctors reported the incident to police after the girl's urine tested positive for drugs.

Her mother, 23-year-old Johanna Bare, and boyfriend, 47-year-old Johnny Carvajal, were arrested last month.

Right now, they are charged with drug possession and child endangerment, but those charges could be upgraded.

The goal of the NY/NJ HIDTA is to measurably reduce crime, particularly drug-related crime, by increasing the effectiveness of information sharing, enforcement, training and prevention among law enforcement agencies in the New York metropolitan area and beyond. Serving as an umbrella for several national model law enforcement partnerships, the NY/NJ HIDTA continues to have a significant impact on the illicit drug trade plaguing the region.

Following is a summary of some of the more notable achievements of CY 2005.

HIDTA Regional Intelligence Center (RIC). The RIC, led by NYPD and located in New York City, has approximately 600 representatives from over 45 federal, state and local law enforcement agencies in the New York metropolitan area. The mission of the RIC is to provide seamless analysis and sharing of criminal intelligence to law enforcement agencies in the New York metropolitan area and beyond -- 24 hours a day, seven days a week.

In conjunction with the HIDTANET (technology) Initiative, the RIC coordinates several critical information sharing programs, including SAFETNet, New York's statewide case deconfliction system (over 41,450 suspects registered in 2005, approximately 38% of which resulted in hits); PIMS, the nation's largest photo-imaging mugshot system (over five million arrest photographs);

and HIDTANET, an information sharing network that links several thousand HIDTA participants through secure network connectivity and email.

The information sharing network of the RIC is linked to satellite intelligence centers in the New York metropolitan area, as well as to the Upstate Regional Intelligence Center (UNYRIC), and to other HIDTA intelligence centers nationwide. The RIC is one of the largest criminal intelligence centers in the country and is widely recognized as a national model.

- The primary mission of HIDTA enforcement initiatives is to disrupt and/or dismantle drug trafficking or money laundering organizations. In CY 2005, the NY/NJ HIDTA disrupted 139 and dismantled 28 drug trafficking or money laundering organizations operating in the New York metropolitan area.
- The illicit drug trade is an extremely profitable business. Seizing the proceeds of illegal traffickers has a significant impact on their ability to function. In CY 2005 HIDTA task forces seized \$26,293,762 in illicit drug profits and removed \$55,683,826 in illegal drugs from the marketplace.
- While the war on drugs is costly, every dollar spent on the HIDTA program in the NY/NJ region resulted in \$3 of drug related assets and \$7 in illegal drugs removed from the marketplace. This equates to a combined return on investment (ROI) of \$10 for every \$1 of NY/NJ HIDTA funds invested.
- The NY/NJ HIDTA strives to investigate larger, more complex organizations, where the most impact will be achieved. Disrupting or dismantling a large complex DTO generally takes longer than stopping a street level operation, but doing so can substantially reduce the illicit drug marketplace. In CY 2005 NY/NJ HIDTA task forces investigated 5 CPOT organizations, initiated 27 OCDETF cases, and targeted 238 organizations that were operating internationally.
- During 2005 the New York OCDETF Strike Force, one of the four enforcement initiatives within the NY/NJ HIDTA, targeted the FARC. The FARC is the largest, most powerful narco-terrorist organization in the Western Hemisphere. The organization is known for its political and military stranglehold in Colombia and has a global position of power in that they control nearly 90% of the world's cocaine supply. This case began in 2004 and in March, 2006 the Strike Force announced the indictment of the FARC leadership, 50 Secretariat and Estado Mayor positions. This case is a prime example of the level of organizations that the NY/NJ HIDTA seeks to disrupt and dismantle.
- The Regional Fugitive Task Force apprehended 3,494 fugitives in CY 2005, 1,576 of which were charged with drug felonies. In addition, 822 were predicate felons, 204 were illegal aliens, and 246 were affiliated with gangs.
- The NY/NJ HIDTA is constantly enhancing cooperation among the many law enforcement agencies in the region connecting the dots. In CY 2005 HIDTA initiatives referred or "handed off" 1,701 cases to other agencies both within and outside the New York metropolitan area.

II. INTRODUCTION TO THE NY/NJ HIDTA

The Federal Anti-Drug Abuse Act of 1988 established the Office of National Drug Control Policy ("ONDCP"), assigning the Director of ONDCP responsibility for implementing the National Drug Control Strategy. Among the powers granted to the Director was the authority to designate areas of the United States as "high intensity drug trafficking areas" ("HIDTAs") and to facilitate the coordination of drug enforcement by federal, state and local agencies within each area.

The mission of the National HIDTA Program is to disrupt the market for illegal drugs in the United States by assisting federal, state, and local law enforcement entities participating in the HIDTA program to dismantle and disrupt drug trafficking organizations, with particular emphasis on drug trafficking regions that have harmful effects on other parts of the United States.

In 1990, the first five HIDTAs were established in New York/New Jersey, Los Angeles, Miami, Houston and the Southwest Border. Today there are 28 HIDTAs, each assessing regional drug threats, designing multi-faceted strategies to counter these threats, and assisting the implementation of these strategies through federal resources.

The New York/New Jersey HIDTA ("NY/NJ HIDTA") is comprised of New York City, Nassau, Suffolk and Westchester Counties in New York and Bergen, Essex, Hudson, Passaic, and Union Counties in northern New Jersey.

The NY/NJ HIDTA is led by an Executive Board consisting of 18 federal, state and local law enforcement leaders in the New York metropolitan area. Their leadership enhances the integration and synchronization of efforts to reduce drug trafficking, while eliminating unnecessary duplication of effort, systematically improving the sharing of drug intelligence, and supporting programs that effectively reduce the demand for illegal drugs.

The NY/NJ HIDTA Director, Chauncey G. Parker, serves at the direction of the Executive Board. He is responsible for the day-to-day coordination of the NY/NJ HIDTA program which currently has partnerships with over 100 federal, state, local, and non-governmental agencies within the New York metropolitan area.


In CY 2005 the NY/NJ HIDTA consisted of 4 major enforcement task forces: Both the NY OCDETF Strike Force and the NJ Drug Trafficking Organization Task Force focus on disrupting/dismantling drug trafficking organizations (DTOs) operating within their geographic areas; the El Dorado Task Force focuses on disrupting/dismantling money laundering organizations and the methods used to launder their crime proceeds; and the Regional Fugitive Task Force focuses on apprehending the most violent fugitives in the area. The HIDTA also supports the Regional Intelligence Center, one of the largest, most comprehensive in the country, as well as both a training and a technology initiative.

The following Annual Report documents the NY/NJ HIDTA's success in achieving the HIDTA Program Goals for January 1, 2005 through December 31, 2005.

2005 Budget: \$ 11,624,441

Designation: The NY/NJ HIDTA was designated in 1990.

■ Geographic Area of Responsibility: The NY/NJ HIDTA is comprised of New York City, Nassau, Suffolk and Westchester counties and Bergen, Passaic, Union, Hudson and Essex counties in northern New Jersey. There are an estimated 15 million people living in the NY/NJ HIDTA region which encompasses approximately 3,000 square land miles.



III. NATIONAL HIDTA GOALS

HIDTAs nationally have adopted two specific goals which guide all HIDTA initiatives and activities throughout the United States. The HIDTA Program goals are to:

- 1. Disrupt the market for illegal drugs by dismantling or disrupting drug trafficking and/or money laundering organizations: and
- 2. Improve the efficiency and effectiveness of HIDTA Initiatives.

<u>Disrupt the market for illegal drugs by dismantling or disrupting drug trafficking and/or money laundering organizations</u>

The NY/NJ HIDTA provides infrastructure support and resources to establish or increase the capabilities of federal, state, and local intelligence driven enforcement task forces, which operationally impact both the regional and national drug markets.

Improve the efficiency and effectiveness of HIDTA Initiatives

The NY/NJ HIDTA combines intelligence and state of the art technology to enhance the integration and synchronization of efforts of the HIDTA Initiatives and the law enforcement community as a whole.

The above goals represent clear targets for the NY/NJ HIDTA initiatives to achieve. They also provide the foundation upon which performance, planning and outcome are measured each year.

IV. THREAT ASSESSMENT

The distribution and abuse of illegal drugs are a serious threat to the New York/New Jersey region. The overall rate of drug abuse in the region is high as reflected in a large number of drug-related treatment admissions, deaths, emergency department (ED) mentions, and arrestees testing positive for drugs. Further, most drugs remain readily available in the region.

Cocaine, both powdered and crack, poses the most serious drug threat to the New York/New Jersey HIDTA region. It is readily available, frequently abused, and more often associated with violent crime than any other illicit drug. Heroin, primarily South American, poses the second most serious threat to the region because of the negative health effects and its emergence and spread within a new, younger abuser population. Marijuana also poses a constant threat to our region. The dramatic increase in the availability Other and abuse of Dangerous Drugs (ODDs). particularly MDMA methylenedioxymethamphetamine), mark these substances as the next greatest cause for concern. Methamphetamine is an emerging threat to the region, particularly in the rural counties of upstate New York.

V. STRATEGY

The NY/NJ HIDTA implements the following initiatives to address the Threat described above as well as ONDCP's two main goals:

Goal 1: Disrupt the market for illegal drugs by dismantling or disrupting drug trafficking and/or money laundering organizations

- New York OCDETF Strike Force disrupts/dismantles drug trafficking organizations with particular emphasis on Consolidated Priority Organization Targets (CPOTs).
- El Dorado Money Laundering Task Force disrupts/dismantles organizations involved in the laundering of the proceeds of narcotics trafficking and other financial crimes.
- Regional Fugitive Task Force identifies and apprehends the most significant drug trafficking and violent fugitives in the New York metropolitan area.
- New Jersey Drug Trafficking Organization Task Force disrupts/dismantles drug trafficking organizations in five counties in northern New Jersey.

Goal 2: Improve the efficiency and effectiveness of HIDTA Initiatives

- **Regional Intelligence Center** centralized location for both law enforcement and commercial databases. The RIC serves as a regional platform for information sharing for law enforcement agencies throughout our HIDTA region.
- **HIDTANET** develops technology to enhance information sharing for law enforcement agencies throughout the New York metropolitan area including deconfliction services, centralized arrest photos and e-mail.
- **HIDTA Training Initiative** increases investigators' effectiveness in combating illegal narcotics and narcotics-related crime, by providing them with no cost training.



Total DTOs Targeted





DTOs Disrupted/Dismantled by Scope





MLOs Disrupted/Dismantled by Scope







Everyday law enforcement officers in the New York metropolitan area face potential life-threatening situations, from executing a search warrant, to investigating "shots fired" on the rooftop of a building, and so on. Until recently, law enforcement did not have adequate facilities to train and prepare officers for these potentially dangerous situations. In 2003, at the request of HIDTA, JTF-6 built the Urban Tactical Village, a four building simulated city street, including a 10,000 sq ft classroom, at no cost to HIDTA other than materials. The HIDTA Training Initiative is now located at the Urban Tactical Village and is a national law enforcement training model.





Charges of Fugitives Apprehended





Predicate Felons Apprehended





Illegal Aliens Apprehended







Recovered Obliterated Firearms Traced







VII. CONCLUSION

In conclusion, any investment with a \$10 return on investment is money well spent. In 2005, HIDTA initiatives removed over \$55 million in drugs from the streets and over \$26 million in drug assets.

HIDTA initiatives disrupted or dismantled 167 drug trafficking and/or money laundering organizations operating in the region.

In addition to the direct outputs of HIDTA initiatives, the services provided to the law enforcement community in general, while more difficult to quantify, result in more streamlined, efficient investigations.

It is impossible to measure the time saved by searching a database of arrest photos rather than signing out photos from binders held at individual precincts, or contacting each individual agency.

It is impossible to ascertain what could have occurred if the 15,873 cases/subjects that resulted in hits had not been deconflicted in either SAFETNet (NY) or SPIN (NJ).

It is impossible to measure the crimes that would have been committed by the 3,494 violent fugitives that were removed from local neighborhoods in 2005.

The NY/NJ HIDTA serves the law enforcement community by gradually breaking down interagency boundaries. By linking federal, state and local agencies together and giving them the technology and resources to accomplish their missions, HIDTA continues to lead the effort to protect the residents of the New York/New Jersey metropolitan area from the harmful effects of illegal drugs.



Regional Intelligence Center (RIC)

The RIC, which is led by the New York City Police Department and located at the NY/NJ HIDTA Center in Manhattan, is the central conduit for information sharing among law enforcement in the New York metropolitan area. The cornerstone of the RIC is the timely and accurate collection, analysis and dissemination of criminal intelligence, particularly drug intelligence.

The Regional Intelligence Center consists of approximately 600 participants and is organized into five sections:

TRAINING

HIDTA Training Initiative

The Training Initiative is located at the Urban Tactical Village in Rodman's Neck with a satellite site at the Long Island Training Center. The Training Initiative provides tactical training to drug enforcement officers throughout the region. The training program is designed to increase investigators' effectiveness in combating illegal narcotics and narcotics-related crime. Classes include software applications (e.g. Microsoft Word, Excel, Pen Link), financial investigative techniques, highway patrol investigative techniques, and both narcotics and canine narcotics investigative techniques, among others. The Training Group also offers classes in intelligence link analysis, interview and interrogation, and foreign language immersion including Spanish, Russian and various Middle Eastern languages.

In 2005, the HIDTA Training Initiative trained 2,750 officers/agents.

ENFORCEMENT

El Dorado Money Laundering Task Force

The mission of the El Dorado Task Force is to disrupt, dismantle or render ineffective organizations involved in the laundering of the proceeds of narcotics trafficking and other financial crimes in the New York metropolitan area. This mission is accomplished by targeting the primary avenues drug traffickers use to launder drug profits: money services, physical transportation, merchandising, banking and brokerages, and bulk cash. The Task Force is led by ICE, and consists of 176 representatives from various federal, state, and local law enforcement agencies. The El Dorado Task Force is also the High Intensity Financial Crimes Area (HIFCA) for the New York metropolitan area.

In 2005 the El Dorado Task Force accomplished, among other things, the following:

- Dismantled 4 money laundering organizations
- Disrupted 79 money laundering organizations
- Arrested 102 money launderers
- Indicted 73 defendants
- Initiated 3 OCDETF cases

Regional Fugitive Task Force

The mission of the Regional Fugitive Task Force is to identify and apprehend the most significant drug trafficking and violent fugitives in the New York metropolitan area. The Task Force is led by the USMS, consists of 184 representatives, and is collocated with the HIDTA Regional Intelligence Center, the New York OCDETF Strike Force, and the HIDTANET and Support Services Initiatives in Manhattan, which greatly increases the resources available to the Investigators.

In 2005, the Regional Fugitive Task Force accomplished, among other things, the following:

- Arrested 3,494 fugitives, of which 822 were prior felony offenders, 1,576 were charged with drug felonies, and 246 were affiliated with gangs
- Closed 4,248 warrants

New Jersey Drug Trafficking Organization Task Force

The Task Force consists of 52 representatives from various federal, state, and local law enforcement agencies.

The mission of the New York OCDETF Strike Force is to use intelligence to aid in trafficking reducing domestic drug and its harmful consequences disrupting/dismantling Consolidated Priority Organizational Targets (CPOTs) and their drug trafficking organization affiliates in the New York metropolitan area. The NY OCDETF Strike Force is a national prototype, placing for the first time OCDETF resources from federal agencies in a single task force at a single location and dedicated exclusively to disrupting/dismantling CPOT targets. The Strike Force is led by DEA, consists of 247 participants and is collocated with the HIDTA Regional Intelligence Center, the Regional Fugitive Task Force, and the HIDTANET and Support Services Initiatives in Manhattan, which greatly increases the resources available to the Investigators.
