44 U.S.C. § 1333

§ 1333. National high school and college debate topics

(a) The Librarian of Congress shall prepare compilations of pertinent excerpts, bibliographical references, and other appropriate materials relating to:

- (1) the subject selected annually by the National University Extension Association as the national high school debate topic and
- (2) the subject selected annually by the American Speech Association as the national college debate topic.

In preparing the compilations the Librarian shall include materials which in his judgment are representative of, and give equal emphasis to, the opposing points of view on the respective topics.

(b) The compilations on the high school debate topics shall be printed as Senate documents and the compilations on the college debate topics shall be printed as House of Representative documents, the cost of which shall be charged to the congressional allotment for printing and binding. Additional copies may be printed in the quantities and distributed in the manner the Joint Committee on Printing directs.

Introduction

The 2009-2010 high school debate topic is: "Resolved: The United States federal government should substantially increase social services for persons living in poverty in the United States."

This selective bibliography is intended to help debaters identify resources and references on the debate topic. The bibliography lists citations to books, congressional publications, federal agency resources, and studies completed by think tanks, university institutes, and private non-governmental organizations. Resources are organized into topical categories (General, Measurements/Definitions/Costs, Cost/Consequences of Poverty, etc.) and most citations include a link to the full text. Debaters may look for these and related resources at their local high school, research, government depository, and public libraries.

The purpose of this debate manual is to provide debaters with a brief overview of the information concerning the 2009-2010 high school debate topic. The compilation is not intended to supply complete coverage of the topic.
