## Center for International Information Technology,

## A Valuable Resource for the Exchange of Information

The Center for International Information Technology (IT) was established in May 1995, in the General Services Administration. Already, it is proving to be a valuable resource for the exchange of information.

The Center, located in Frank McDonough's Office of Information Technology, is headed by Wanda R. Kopacz. Since its inception, the Center has facilitated the exchange of knowledge, ideas, and experiences in international, state, and local governments. Delegations from several governments have visited the Center in recent months. GSA managers emphasize that the two way dialogue provides good information to be used here in the US as well as to the visiting delegations. In most instances, visitors are interested in how the United States handles emerging issues such as reinvention, downsizing, performance measures, electronic commerce, and business process re-engineering. Representatives from

Australia, Canada, Denmark, Jamaica, Japan, Malta, Norway, South Korea, and Sweden have visited in recent months.

The Center is developing a concept to share practices found to be successful in state governments. These will be shared with other national governments. Frank McDonough will present this idea at ICA's Spring meeting. He said that identifying the "best of the best for the common good" continues to be a top priority in ICA.

In 1996, you will see two additional issues of *ICA Information*. Issue 58 is the eagerly awaited *ICA E-Mail Study Group Report*. The Chairman of the Group, Poul Bernt Jensen and his team have produced an excellent report which is now at the printers. Poul's team had representatives from eleven countries in four Continents. Internet played an important role in the drafting processes.

The *ICA General Issue*, the 59th in the series, is now being planned. Each year, timely articles of interest and value to all member nations are printed in this publication. An article may be new research, an update of a presentation previously given at a Conference, or a preview of an upcoming attraction. Many articles describe new work that the author believes may have a wide value. Other articles share experiences. The choice to publicize your work is one that only you can make.

In Malta, I received a number of offers of articles for the next *General Issue*. Please take this as a reminder that the target date for receipt of articles is April 7. There is still time to make a contribution to the *General Issue*.

As a guideline, articles should be between 1,000 and 5,000 words and should be sent to the editor in both electronic (3.5 inch diskette) and paper copy. It would be a great help if any illustrations or diagrams are also copied onto the diskette.

Text in WORD format is recommended but both ASCII and WordPerfect can be read without difficulty. All diskettes should be clearly labeled; and, all articles should be prefaced by a short biography of the author. An early alert advising me that an article will be provided would be appreciated. *ICA Information* is always a good value. With your help, the next *General Issue* can be the best ever.

## ICA Proceedings: Simple Guidelines to Keep the Costs Down

The *Proceedings* of the successful 29th ICA Conference raised some familiar issues. At the ICA Council Meeting in Malta last October, the cost of ICA publications was a major topic.

Once again, the *Proceedings* are longer and heavier than in previous years. The cost of publishing the Conference *Proceedings* is the largest single item in the ICA budget. Broadly speaking, it accounts for some 40% of income in a normal year. The 400-plus page publication will weigh over 1 kilogram.

National Representatives are requested to follow a few simple guidelines. These will make a substantial difference in the costs and in the time it takes to publish the *Proceedings*. The single most important message is to use the available technologies to reduce costs. All materials (text and diagrams/ illustrations) should be provided in both electronic and paper copy. Whenever possible, use WORD or one of the widely available word processors (ASCII, WordPerfect or Ami-Pro). Keeping the Round Table reports within three to six-pages is important.

These guidelines will enable us to provide better service to you. For example, for on-time submissions, we will be able to provide electronic copies of all Round Table reports in Budapest.

## **Electronic Filing: Current Possibilities and Recommendations**

Since January 1, 1996, the State Archives has made it possible for public institutions to introduce full electronic case administration and filing systems. Denmark has become the first country in the world where a national registry authority allows public authorities to discontinue using paper archives and introduce full electronic filing systems.

The transition to electronic case administration with the public authorities and institutions is a major element in the Danish government's *IT Political Action Plan, 1995*. The implementation of these objectives requires careful consideration of the filing of electronic documents to ensure that the archives can be used as historical documentation in the future.

Electronic case administration in government is as much a cultural and research factor as a technological challenge.

With this publication and a circular from the State Archives regarding electronic filing, Denmark is taking the first major step. Documents which are "born" electronic should also be filed electronically and not in a paper archive.

The Ministry of Research and Information Technology and the State Archives will closely follow technological change to ensure that the guidelines are adjusted on a regular basis.

The State Archives also intends to track the use of information technology in public administration. The authorities can therefore enter into special development agreements with the State Archives regarding the organization and filing of electronic materials.

This publication and the circular will help push forward the introduction of electronic case administration and filing systems and in this way help make public administration more efficient.

The IT procurement organizations which will succeed in the future are the ones that demonstrate the leadership, flexibility and will to examine the way they do business, and the courage to change. By taking the steps outlined in the publication, procurement organizations can balance the need for effective customer service with their traditional role of enforcing compliance with law and regulations.

## Controlling Information Technology Within the Swiss Federal Administration

The Consulting Section of the Swiss Federal Office for Information Technology and Systems has been authorized to develop **Controlling** methods for applications using information technology.

By Controlling we mean a systematic and continuing process of verification and guidance, which is applied to the life-cycle in the development of an information system.

With a formal structure for Controlling Methods, the decisions which guide the development process can help ensure better management decisions.

Controlling is a tool for leadership. Successful control depends on maintaining a transparency between cause and effect. Good leadership requires taking responsibility for decisions made.

Applied in the various offices of the Swiss Federal Administration, these new methods will encourage a target-oriented management of investment in information technology.

Within a project framework, a handbook of guidelines is being created, together with a corresponding organizational structure and appropriate training courses.

Controlling is applied in parallel with each of three life-cycle phases:

(1) strategic controlling (in the initialization phase),

- (2) project controlling (in the implementation phase), and
- (3) application or system controlling (in the operations phase).

## **Guidelines for Information Technology Standards**

The Royal Ministry of Government Administration in Norway has translated into English their publication titled *Guidelines for Establishing Government Standards for Information Technology (IT) in the Public Administration*. This document was originally issued in March 1995.

Standardization can foster opportunities for interaction and efficiency between government agencies at all levels. It can also provide similar opportunities with the private sector and beyond national borders.

Standardization work is especially important in the field of IT. The guidelines set forth in this document should constitute a common foundation for the work of the various stakeholders in drawing up governmental standards. The areas that are particularly appropriate for work on governmental standards are-

Data definitions and information interchange;

- General requirements for government business applications;
- Procurement and systems management; and
- Technical infrastructure.

It is important to note that a Secretariat for IT standardization in public administration has been established. It will help coordinate standardization work, assist in drawing up proposals for governmental standards and their maintenance, and develop guidelines for Ministries.

### **Results of the ICA's Recent E-Mail Study Group**

In Vienna, in October 1994, ICA's Council of National Representatives identified data sharing and data management as one of the top issues for the 1995 Study Group. The 1995 Study Group emphasized electronic mail as its first subject. Poul Bernt Jensen (Denmark) was elected to chair the ICA E-Mail Study Group at a meeting in Copenhagen in June 1995.

The E-Mail Study Group evaluated the status of national and international electronic mail systems, considered the organizational and technical issues involved, and recommended actions to ensure the effective use of this technology between organizations and countries. These objectives were a challenge because of the different approaches being taken in ICA Member countries. It also is complicated by the variety and incompatibility of the products, services, and systems used in each country.

E-mail was used extensively throughout this study. Ten of the 11 Study Group members had access to e-mail, either X.400, Internet or both.

E-mail was a useful tool to distribute working and final documents, make and confirm meeting arrangements, and provide comments on draft reports. E-mail provided a convenient, timely, and practical way to communicate when participants were located throughout the world.

E-mail was found to be an effective tool to support communication and exchange of information over distance and time. Extensive exchange of e-mail occurred even though some members never met in person. Friendly relationships developed easily.

This easy and informal method of communicating has real potential to support groups working across human and geographical boundaries. However, a few group members with little e-mail experience did hesitate; and, along with those without e-mail access became isolated in the Study Group's work.

It was the experience of the group that using e-mail on X.400 to X.400 and Internet to Internet protocols functioned without significant problems. File attachments were received in good condition and were easy to use. However, exchanging e-mail and binary file attachments between unlike mail protocols caused the greatest problems because of the lack of standards.

Using uuencoding and MIME protocols did overcome some of these problems. However, these required some coordination between the sender and the receiver, additional software to encode and decode messages, and more knowledge on the part of the user.

## Insights from a US Conference on Virtual Government

Several initiatives were highlighted in a recent conference on Virtual Government held in the United States. These initiatives are consistent with the theme of the 30th ICA Conference in Budapest.

Now at the concept and pilot stage, the Department of the Treasury is implementing a system for single point filing to reduce the reporting burden on companies. The Simplified Tax and Wage System (STAWRS) combines the requirements from the Social Security Administration, Internal Revenue Service, Department of Labor and state governments. A working model is expected by December 1996.

The US Postal Service is implementing a joint initiative between the Federal, state, and local governments to allow taxpayers to receive one-stop shopping services through personal computers and kiosks. A series of integrated services will be available that are build around a person's life. For example, when a child is born, the parents may request a birth certificate, social security number and immunization record. Information is available on the Internet at **wings.usps.gov**.

To make government services more easily available to the poor and disadvantaged who often find the complexity of government paperwork too difficult, the Social Security Administration is implementing the Georgia Common Access Project. This paper-based program consolidates the requirements of four Federal agencies, state, and local governments in the state of Georgia. The project is operating in 20 neighborhood clusters.

In the state of Oregon, citizens will be able to give their name, social security number and address and the Oregon Pathways will be able to provide information to the customer from 30 different programs in 13 Federal, state, and county agencies.
