PROVIDING FOR CONSIDERATION OF H.R. 5684, UNITED STATES-OMAN FREE TRADE AGREEMENT IMPLEMENTA-TION ACT

Mr. Hastings of Washington, from the Committee on Rules, submitted the following

REPORT

[To accompany H. Res. 925]

The Committee on Rules, having had under consideration House Resolution 925, by a record vote of 7 to 3, report the same to the House with the recommendation that the resolution be adopted.

SUMMARY OF PROVISIONS OF THE RESOLUTION

The resolution provides for consideration of H.R. 5684, the United States-Oman Free Trade Agreement Implementation Act, under a closed rule. The rule provides two hours of debate in the House equally divided and controlled by the chairman and ranking minority member of the Committee on Ways and Means.

The rule waives all points of order against consideration of the bill. The rule provides that pursuant to section 151 of the Trade Act of 1974, the previous question shall be considered as ordered

on the bill to final passage without intervening motion.

Finally, the resolution provides that during consideration of the bill, notwithstanding the operation of the previous question, the Chair may postpone further consideration of the bill to a time designated by the Speaker in consonance with section 151 of the Trade Act of 1974.

EXPLANATION OF WAIVERS

The waiver of all points of order against the consideration of the bill includes a waiver of section 302(f) of the Congressional Budget Act (prohibiting the consideration of legislation providing new budget authority for any fiscal year that would cause the applicable allocation of new budget authority made pursuant to section 302(a) or (b) to be exceeded). The bill violates section 302(f) because its direct spending will exceed the Committee on Ways and Means' allocation by \$1 million over the first year.

In addition, the waiver against all points of order against consideration of the bill includes a waiver of clause 3(c)(4) of rule XIII (requiring the inclusion of a statement of general performance goals and objectives in the committee report).
