Submitted for your consideration is an amendment to your FY 2009 Budget for the Department of the Interior. This request would delete two provisions that exclude certain areas of the Outer Continental Shelf from oil and gas leasing. This action is consistent with your decision to lift the Executive withdrawal of these areas and your call on Congress to lift their legislative moratorium on leasing lands for energy production. Overall, the discretionary budget authority proposed in your FY 2009 Budget would not be affected by this proposal.

I have reviewed this request and am satisfied that it is necessary at this time. Therefore, I join the Secretary of the Interior in recommending that you transmit this amendment to the Congress.
